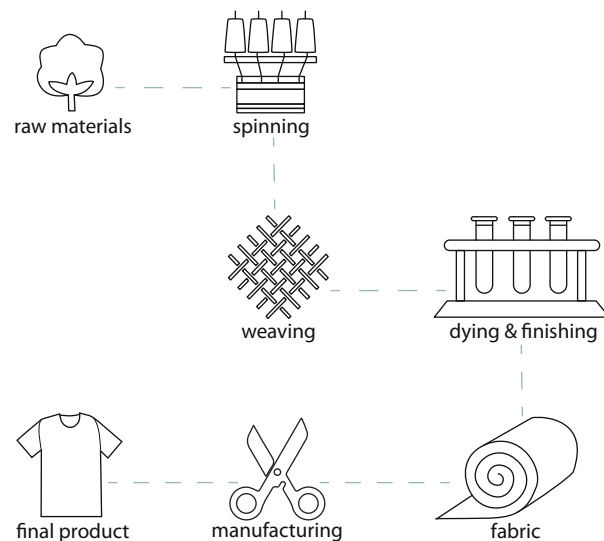
# Better Cotton Initiative.

It is the largest program in the world for the sustainability of cotton production, aimed at reducing environmental stress and promoting the well-being of farming communities.

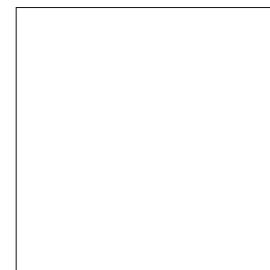

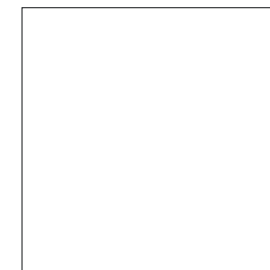

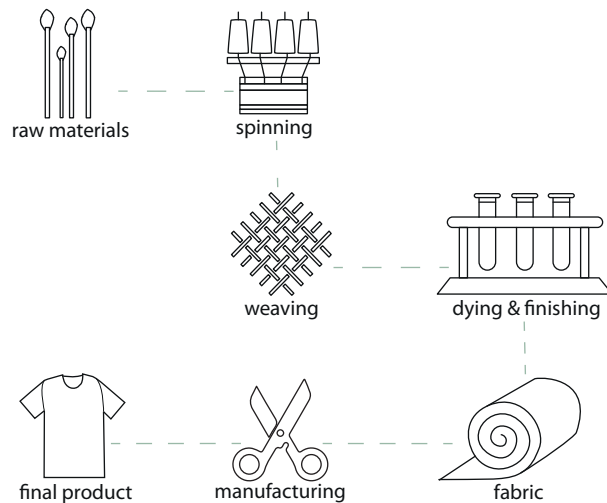
# The European Flax.

The EUROPEAN FLAX® Charter, signed by all the Flax producers, guarantees local farming that respects the environment and commits to zero irrigation, zero GMO, and zero waste. Fibre extraction (scutching) is 100% mechanical meaning zero chemicals are used in the process.

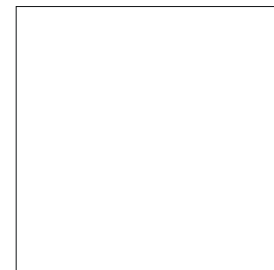

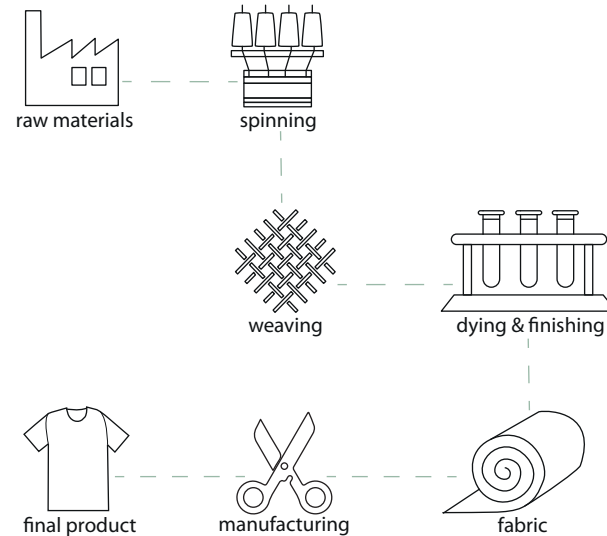
# Global Organic Textile Standard.

GOTS is recognised as the most important standard for sustainable production of garments and textile products made of natural fibres from organic farming such as organic cotton or organic wool.

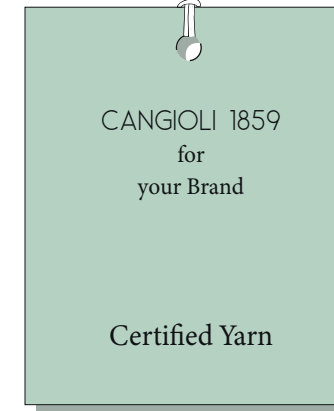
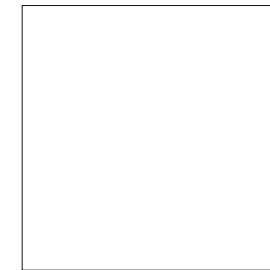

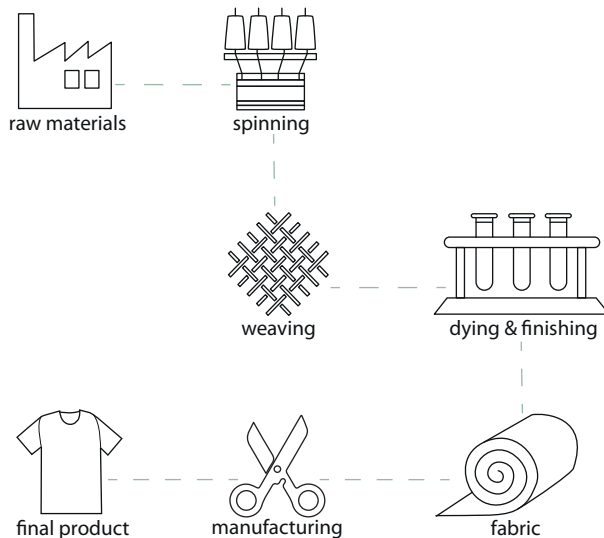
# Global Recycled Standard.

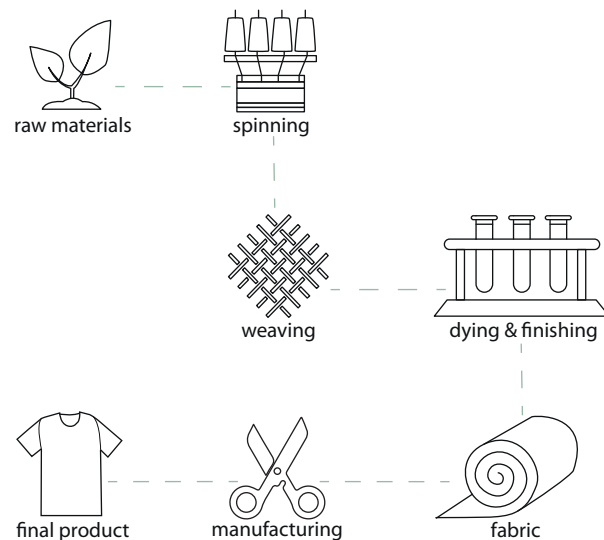
# Organic Content Standard.

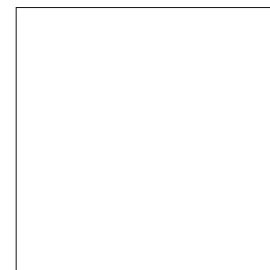

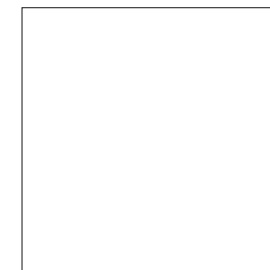

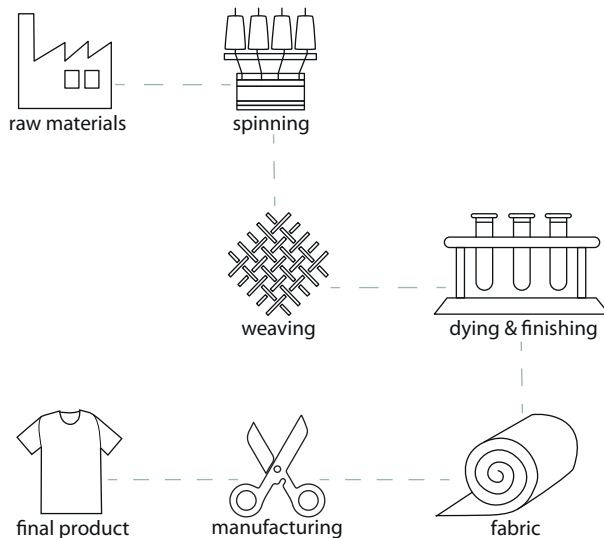
# Recycled Claim Standard.

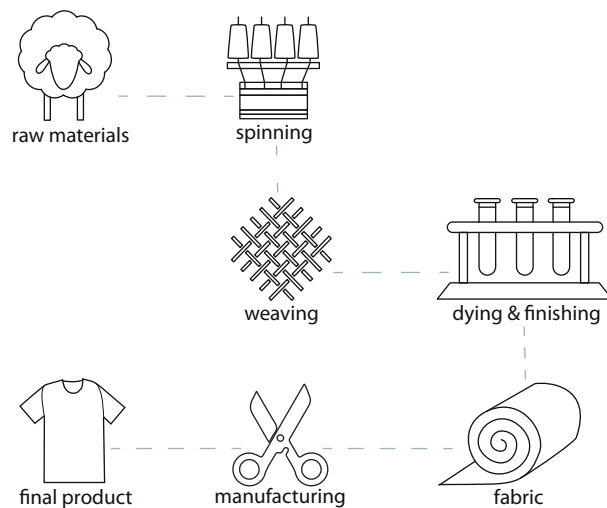
# Responsible Wool Standard.

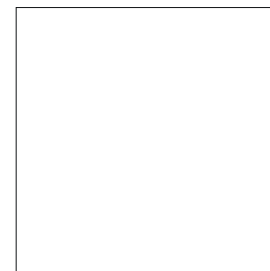

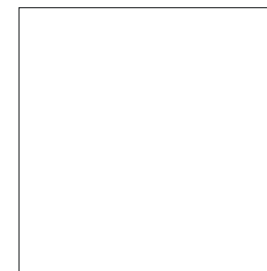
